# A THERAVADA BUDDHIST COUNSELING FOR SOLVING PROBLEMS OF THE HUMAN RIGHT VIOLATION AND ITS RELATION TO THE PRESENT SOCIETY

## ABSTRACT

This article entitled "A Theravada Buddhist counseling for solving problems of the human right violation and its relation to the present society." Which is consists of two objectives: To analyze the Problems of the human right violation in Today society, and its Elimination from Theravada Buddhist Counseling. This paper critically investigates Buddhist understanding of the concept human right and exploring practical teachings on overcoming the actions of ethical, socio-political, sexual violence, and religion conflicts. Buddhism beliefs that violence and conflicts are grounded on human desires in terms of attachment. It means that the attachment produces an immoral act which is defined as violence and conflict. The researcher also considers Buddhist moral values in the way of controlling the violent actions and promotes Buddhist concept of human right. In the first section, the researcher draws the attentions on the problems violation in today society, in the second section considers Buddhist guidelines on controlling of the violence, and lastly concludes the significances of the study.

# Introduction

The concept of human rights has been taught by the many religions of the world including Buddhism. Buddhism is one of the school which promotes the value of human right to human society. The Buddha enlighten by realizing that the human world is full of sufferings such as Ethical, social-political, sexual violence, and religious conflict, and he himself discover the way how to be free from those sufferings as well as taught his followers how to overcome the suffering. He sees that all violence and conflicts are caused by human attachment, anger, greed, ignorance, and jealousy. It is to say that the foundation of Buddhism very based on intellectual freedom from those elements of suffering by understanding the causes and effects. This article will observe the teachings of the Buddha, which is helpful to solve the problems of human rights violation and how it has eliminated by Theravada Buddhist counseling.

# 1. Ethical violence in society

Ethical violence are eight non-virtues actions, killing, stealing, sexual misconduct, tellinglie, abusive, indignity, disappointment, drinking alcohol.<sup>1</sup> These are ethical non-virtues of the types: *body action non-virtues*, and *verbal action non-virtues*. In this section, firstly, the researcher demonstrates the characteristics of ethical non-virtues.

Killing is one of the ethical non-virtues, there are two kinds of actions which are mercy killing and suicidal killing. Mercy killing makes kill someone based on compassion. Even though, this action is so bad ethics. Someone who would like to be liberation from any suffering of body and mind. Thought, he cannot be freedom end of suffering mind and matter. Therefore, mercy killing is a bad ethic. because mercy killing is depending on bad act. For example, some doctor makes a person who would like to be free from any suffering die by the compassion. So that when

someone died, the doctor is feeling in his mind, he did not get happiness because mercy killing makes ethical violence. These are the bad advantages of mercy killing.

Some scholar who says that mercy killing is a good ethic for the people who are psychological suffering. Thus, the regarding mercy killing can make him free from any mental and physical suffering. This is a negative issue with the misunderstanding on mercy killing. Thought, Good ethic is not to do any killing. Therefore, the researcher referring to all killing as a non-virtue for a living being peacefully together with the other human being. Mercy killing is an ethical violation. Moreover, suicidal killing is one of the psychological problems based on negative emotions which are anger, craving, hate, and ignorance. Because the researcher regarding the suicidal killing makes his ethics die himself. For example, someone who makes suicide kill himself is dying his ability, good action, and ethics. This issue, the suicidal killing is one of the ethical violations.

Stealing is one of the ethical violations which is depending on economic caused by poor and poorly economic. For example, someone who takes things who didn't give them. S/he is broking a value of human rights. Therefore, everybody rejected a relationship with his or her. So that, s/he is unlucky or unhappy in the present life and s/he will be the bad reaction of broking ethics in the future life. This issue, stealing is one of the ethical violations of human rights.

Additionally, some scholar who says that stealing is a huge problem caused by craving, attachment, and ignorance. For example, some person who is stealing other things that did not give it. therefore, s/he may create a problem of social distance with the other friends. Thus, s/he is the social distance between them. Then stealing is a human problem that depends on an imbalanced economy caused by craving. It is an unwholesome caused reaction of the non-values. Thus, there are so many problems based on stealing action in society today. It is one of the ethical violations of human rights. It is one of the bad reactions to stealing. This issue, stealing is an ethical violation in today's societies.

Even thought, the researcher found that some stealing is good virtues based on wisdom. According to these issues, stealing is a good ethic for people who are different views. For example, some people who have to steal good activities, ethics, and moralities from different cultures, religions, and learning are in becoming a better person. Therefore, some stealing is a good ethic. It is a good reaction to stealing. Although, the researcher found that some person who has practice stealing for own benefit is not a better person. On this issue, stealing is good or bad depending on the issues. It regarding be taken idealities from the different culture, religions, and learning. This issue, some stealing is good virtues based on positive issues. it is one of the critical issues on the stealing of idealities from different cultures.

Sexual misconduct is one of the huge ethical violence in human rights.<sup>2</sup> It is based on positive desire or negative emotion. Thus, there are so many social bad problems in today's society. For example, some person who was sexual misconduct, s/he is been a pleasure at just time but s/he cannot be happiness. Therefore, s/he is creating the benefit reaction of sexual misconduct. It is one of the ethical violence in societies today.

The researcher critically thinks that sexual right conduct is happiness for peace with harmonious based on desires. Here, there are two types of desires, they are sexual desire and pleasure desire it regarding the sexual desire for happiness, it's absolutely right. Therefore, sexual desire is a virtue for peace and a more harmonious world, a friendlier world. Though, pleasure desire is very useful for the development of social ethics and social relationships. These issues, sexual right conduct is happiness for peace with harmonious in human society. Sexual misconduct is an enter problem based on positive emotion that is craving or attachment. Thus, sexual misconduct is a huge external ethical violence in today's society. although, sexual right conduct is mental happiness depends on physical pleasure. For example, some person who can be sexually

Furthermore, telling-lying is one of the non-virtues based on craving.<sup>4</sup> Then. thus, telling-lying can create ethical violence. For example, some person who can telling-lying because who cannot believe in his business friends. So that may create one of the social problems that depend on telling-lying for the relationship between each other peoples. it is vitally important to cultivate self-confidence with other some friends. because telling-lying is one of the ethical violence based on craving. Also, telling-lying is one of the non-virtues-based jealousy. Then, it is regarding the cause of the telling-lying is jealousy. This jealousy can create telling-lying. Then, telling-lying is social conflict. This issue, telling-lying is ethical violence based on jealousy.

Telling-lying is one of the non-virtues based on anger, which is referring to a cause of the telling-lying. This anger can create telling-lying. Then, telling-lying is been social hate. Thus, telling-lying is been social hate problem. Therefore, telling-lying is ethical violence based on anger. Moreover, telling-lying is one of the non-virtues based on hate. This hate can create abusive, indignity, and disappointment because, the researcher discovered that hate is an abusive, indignity, and disappointing. This issue, telling-lying is related to abuse, indignity, and disappointment by the craving, anger, and hate.

The scholar who says that someone telling-lying is cause for happiness. he regarding tellinglying did not have craving, anger, and hate in mind. Thus, telling-lying is a cause for happiness. Then, telling-lying is not been bad feedback of action. *because* he did not have a mind in this tellinglying. Therefore, telling-lying is not to be ethical violence. Moreover, according to critical issues

that telling-lying might be good friend, ethics, good action, happiness life, and peaceful life. Sometimes, if one says that telling truth, we will be a bad result of the telling-truth. For example, someone who went to borrow some money from you. At the time, the borrower says that if you cannot give me some money, he will kill you. At the time, how to say that telling-lying or tellingtruth. If you say that, telling-truth you will die at moment. Because, sometimes we should do tellinglying for a good friend, ethic, action, happiness lives and peaceful life in the world. It is one of the critical thinking of the telling-lying based on loving-kindness and compassion.

Drinking alcohol is one of the non-virtues in human societies. Then, drinking alcohol is one of the ethical violence for everyone.<sup>5</sup> Then, there are so many problems based on drinking alcohol. For example, some person who was drinking alcohol might be killing, stealing, and sexual misconduct so on. Therefore, drinking alcohol is a major bad ethic for the harmony's human society.

Even though, some scholar who says that drinking alcohol is one of the ethical activities for the basis of social human right. Thus, so many people could love to drinking alcohol to develop a social relationship with each other friends, or group. Because he mentions that drinking alcohol is a good ethic for social relationship each other people who are friends and group. It is one of some scholar's issues. although, drinking alcohol is ethical violence based on craving, anger, and ignorance. Therefore, drinking alcohol is one of the non-virtues. This issue, drinking alcohol is a major ethical violence in today's society.

#### 2. Social conflicts in Society

Social conflict is that self is a social problem based on non-cooperation caused by craving, attachment, hate, and jealousy. There is a different Self which is I, me, my, mind myself. Then, there is you, your, yourself. Thus, they may create stratification based on craving, attachment, and

In regards to social violence based on jealousy. Therefore, they created stratification based on different selves, family, duties, groups, nations, countries, laws, and learning. It is referring to social caste, it comes from our minds, craving, attachment, and jealousy.

Social violence is one of the problems of humankind based on the stratification of the self, cultures, nations, colors, and groups. Then there is so much social violence based on different nations and groups, families, legal laws, actions, skills, and abilities. For example, some person who has stratification based on self-love and self-ethics. so that, they may create social violence in human societies. Therefore, social violence is a problem of human kinds based on individual culture, learning, nations, ethics, legal laws, actions, skills, and abilities.

Additionally, the negative concept is one of the social problems that depend on various thinking. For example, some person who has negative thinking can create social problems. Then, he is can be social violence based on critical thinking; one of the intellectual problems depends on the negative concepts. Therefore, the negative concept is a social problem in various thinking. It is one of the psychological problems. Other examples, some people who have wrong views can create negative emotion. This issue, the negative concept is able to be one of the social violence based on various concepts. It is led to human rights violations.

The negative emotion is one of the social problems that depend on objects of our mind. Then, negative emotion is a psychological problem based on the monkey mind. For example, someone who has negative emotions because he can create so many social problems in human societies. Negative emotion is the problem of social violence in human society, therefore, this issue,

These are causes of negative emotions. For example, someone who has craving, anger, hate, and jealousy can be negative emotion by the wrong views Therefore, we called him is a negative person who can create social violence. This issue, negative emotion is social violence. It is led to human rights violation.

Self-love is one of the negative emotions based on craving and attachment. Such as in family's love. For example, parents who have self-love in their sons and daughters is a social conflict for other families or groups. It is can create social violence. Other example, someone who is girlfriend love his boyfriend by caused self-love. Thus, self-love is a social problem, it led to human rights violations. Then, it regarding a psychological problem in mental state. Therefore, self-love is social violence based on craving and attachment. These are issues, self-love is one of the non-virtues based on a narrow mind.

Moreover, Anger on compassion (*karunãdosa*)<sup>7</sup> is one of the causes be of social problems between teacher and pupil, parent and Children, and monk and disciples. For example, some father who would love to make his son a doctor when his son was not a doctor, is anger based on compassion. Therefore, they can create a social problem by compassion. This issue, social violence caused by anger on compassion (*karunadosa*). It is led to human rights violation.

In this situation when you see him, you will be fee-based on compassion depends on killing being died. Therefore, compassion is one of the psychological discriminations based on the suffering of other beings.

Even though, compassion is one of the good virtues for protect living being peacefully together with the other human being. This compassion is a good social ethic based on loving-kindness for a relationship between person and group. Therefore, compassion is not a psychological problem. Moreover, compassion is not with anger. Compassion is one of the causes of merit. Although, according to the general, logical concept, compassion is to be social violence depending on emotion with anger. This issue, compassion is a psychological problem. It is led to human rights violations.

Additionally, hate is one of the non-virtues based on anger. Then, it regarding non-loving kindness. Thus, hate is a social problem for relationships between one group or other group and one family or another family. For example, in our country, there are so many groups or parties that are different emotions based on various concepts. Then, they can create so many social problems by the hate. This example discovered hate is to be social violence. Therefore, hate is one of the non-virtues based on anger. This issue, hate is social violence caused by anger.

Moreover, jealousy is one of the non-virtues based on craving. Then, it referring to nonjoyful. Thus, jealousy is a social problem for relationships between family groups and people. For example, in the US, there are two parties, republican or democratic who are different emotions based on views. Then, they can create dangerous social problems by jealousy. This example is present-day in 2021. According to these issues revealed jealousy is to be social violence. Therefore, jealousy is one of the non-virtues based on craving. these are social issues, referring to the social conflict based on self-ethic, culture, concept, emotion, compassion, anger, hate, and jealousy. This issue, social conflict is led to social violence with problems of human beings in today's society.

Furthermore, Non-cooperation is one of the social problem in societies who are different religion, cultures, ethics, and learning. Thus, non-corporation may create social conflicts in society. There are many non-corporations based on self-religion, cultures, ethics, and learning. Therefore, they may create social problems in human society. For example, in some of the country there are so many national groups, and parties. So that they cannot corporation with the other groups and party caused by jealousy, craving, and hate. This will be social problems are based on non-corporation. This issues, non-corporation is one of the social conflict. It is lead to social problem in society.

In conclusion, the researcher believe that social conflict is one of the huge problem based on non-cooperation caused by craving, anger, attachment, hate, and jealousy. This is why, they create different culture, religion, nation, and learning. Therefore, there are social conflict based on non-cooperation.

# 3. Political conflict in society

Political conflict is one of the huge human problems based on dishonesties discrimination related to societies. Then, there are so many different types of groups such as different nations, cultures, and religions. Therefore, they were so many problems of political conflict based on different societies or groups. For example, in our country, they created political conflict based on different groups or parties such as NLD and USDP. Then, they have so many problems of political conflict conflict based on different groups or parties such as NLD and USDP. Then, they have so many problems of political conflict based with discrimination.

Moreover, political conflict is creating problems for human beings depends on individual concepts. Then, they are so many problems based on a various concept. For example, some party's people who have negative concept can create other party's problems. because they can make

discriminate between two more parties who have a negative or positive concept. Some people who have self-love, self-laws, and self-ethics can make political violence based on a negative attitude. Even though, some party's people who have liberal concept, laws, ethics, and action does make peace based on positive attitude. Therefore, they can create non-political conflict based on a liberal concept. This issue, political conflicts is social violence caused by individual negative concepts in today's society.

Additionally, self-love is one of the non-virtues to be a problem of political conflict. then, they are craving, desire, attachment, anger, hate, and jealousy. For example, some people who have a craving in their mind can create political conflict by craving, desire, and attachment on individual laws, and ethics of their party. because, they cannot cultivate liberal legal laws, ethics, action, benefit, and concept. Therefore, this is one of the political conflicts caused by narrow minds. These are issues, political conflict based on individual self-love by caused craving, anger, hate, and jealousy in today's society.

Self-law is one of the non-virtues based on societies or groups. For example, some groups who have self-law can make a better benefit for own their family or society, it was not balanced laws for everyone. thus, they can make unbalanced legal laws for other families, people, or groups. Because they can create problems of political conflict by the self-laws. Even though, balanced law is one of the virtues for who needed to be living being peacefully together with the other human being. Therefore, balanced law can create non-political conflict for everyone. This issue, political conflict is depending on individual laws. Like that, self-ethics is one of the non-virtues to be the problems of the political conflict based on craving, desire, and attachment. For example, some individual ethics is not balanced for everyone who is different from birth, colors, families, duties, and learning. Thus, self-ethics can make the problems of socio-political conflict. Therefore, self-ethics is one of the non-virtues based on desire, and attachment. This issue, the political problem is depending on individual ethics, it leads to political violence. it is led to human rights violations.

Some scholar who says that positive craving is one of the psychological problems in our mind. Such as narrow mind (*Loba*), desire (*Ragasanda*), and attachment (*Upadan*).<sup>8</sup> Then, positive craving can create political conflict. Therefore, positive craving is to be a psychological problem based on desire. Therefore, positive craving can make political problems such as political and ethical violence. these are concepts, positive craving is to be political violence. it is led to human rights violations.

The researcher who originated that positive craving is a psychological problem based on attachment (Upadan).<sup>9</sup> then, positive craving can create political conflict by attachment. For example, someone who has a craving mind can create negative party's problems such as unbalanced laws, action, ethics, and human right violation. This example, show that positive craving can make political violence. Therefore, positive craving is to be a political problem based on attachment in-laws, actions, ethics, culture, and learning.

Even though, one critical concept is positive craving for business life, social life, and family life. For example, some person who is a businessperson can do successful business life based on positive craving. because, positive craving is one of the causes to develop economic, social life, and family life based on positive craving. Therefore, positive craving is a good and a bad reaction depends on individual emotion. These issues, positive craving is not a problem of the political conflict between one party or other party and one country or with other countries.

Although, sometimes this anger can create political conflict caused by hate. Thus, positive anger is to be a problem of political conflict based on hate. Even though, negative anger cannot create political conflict because negative anger is depending on positive thinking. For example,

Then, there is so much anger based on negative emotions. It leads to political conflict. This issue, positive anger is one of the courses, political conflict based on psychological problems. it is led to human rights violations.

Even though, the researcher discovered that positive anger based on afraid of the mind. Then, there are so many types of positive anger in our mind such as worry, unhappy and negative emotion. Thus, positive anger can create political conflict caused by afraid of the mind. For example, someone who has positive anger can make ethical violence such as killing, stealing, and tilling-lying then, it leads to political violence. Therefore, positive anger is political violence on the afraid of mind. It is one of the psychological problems based on afraid of the mind, regarding positive anger. This issue, positive anger is to be political discrimination in today's society.

However, some scholar who says that political conflict comes from dishonesties, which is non-virtues such as positive jealousy, anger, craving, and ignorance. He regarding psychological problems based on discrimination related to social caste. According to this concept, Positive jealousy is one of the psychological problems in our mind. Therefore, jealousy can create political conflict in human problems. For example, someone who is positive jealousy in his mind on the other successful people or parties can create a political problem. This issue, one of the positive jealousies created political conflict in today's societies.

Moreover, Positive hate is one of the psychological problems based on discrimination. Such as negative people or groups. Then, this hate can create political conflict based on discrimination. For example, some people who have positive hate can make do socio-political conflict. Thus, positive hate may create so many problems in human society. These are issues, hate is to be political conflict based on discrimination. Even though, some scholar who says that positive hate is political violence based on jealousy, anger, and negative emotion. Then, he regarding social hate, political hate, and personal hate. Therefore, a positive hateful person can create problems for the negative person or society at every location. These are issues, Positive hate is to be political violence based on anger.

Additionally, positive hate is one of the psychological non-virtues based on jealousy. Such as unhappy, sorrow and unjoyful then, these hates make psychological problems caused by jealousy. For example, some people who have positive hate is psychological problem, unhappy, sorrow and unjoyful by jealousy. Thus, positive hate can make socio-political violence on other negative people who are indifferent parties or groups. This issue, positive hate is to be a sociopolitical conflict based on jealousy. Therefore, positive hate is one of the psychological non-virtues.

Moreover, one perspective, positive hate is one of the psychological non-virtues based on negative emotion. Such as, personally hate. Then, this hate can be improving anger and jealousy by other people's activities. Thus, positive hate is a socio-political conflict based on negative emotion. It is referring to psychological discrimination. Therefore, they are so many problems depending on positive hate. These issues are political conflict or political violence caused by jealousy, anger, emotion, and hate with the caused problem.

Let my conclusion, these are issues, political conflict is depending on individual concepts, legal laws, ethics, and self-love. Then, it regarding psychological discrimination. These are based on craving, desire, attachment, anger, hate, and emotion. Therefore, there are dishonesties by the political people. These are why, the researcher believe that they can make the problems of political conflict based on individual negative concept, unbalanced laws, ethics, and action. This issue is political conflict is depending on dishonesties with the discrimination.

# 4. Sexual violence in society

Sexual violence is one of the non-virtues' actions based on craving, attachment, and ignorance. then, sexual misconduct, abuse, child rape, persecution, and harassment. Then, there are so many problems based on sexually abusing such as child rape everywhere. Therefore, the researcher discovered sexual violence is a huge human problem.

Sexual misconduct is one of the huge human problems by caused cravings.<sup>10</sup> Then, there are both problems for family and personal ethics. Thus, sexual misconduct can make marriage problems. These problems led to sexual violence. Thus, sexual misconduct is one of the huge human problems. For example, some person who takes sexual misconduct with other his wife can create bad problems such as killing, telling-lying, and stealing. Therefore, this example shows that sexual misconduct can create all human problems. These issues are, sexual misconduct led to human problems by sex mind.

Although, these problems are can create everything by critical thinking such as good problems or worse problems. Then, some problem is making happiness other people. This problem is good action by natural laws. For example, some sexual misconduct is not sexual abuse. Thus, sexual activities are for the happiest physical pleasure. Therefore, some problems can make happiness for the people who did not accede to any create laws, ethics, and dignities. Even if, the bad problem is making unhappiness other people. Some sexual misconduct makes sexual violence such as child rape, and sexual abuse. Thus, a bad problem may make suffering for other human life. These are an issue; the problem is good or bad depending on individual emotion or activities of people.
